

In 2020 the Foundation raised \$1.9M and deployed over \$2.2M in support of it's programs. As per the above graph the organization has traditionally spent less than their revenue so it is nice to see some of this excess capital being deployed into the sector. They do not receive any government support and the majority of revenue is received from other income sources outside of receipted gifts. Perhaps membership fees or corporate sponsorships. They give nearly 70% of their revenue to other registered charities in Canada with just 8% going toward Administration. All of their work is focused on support the Ukraine communities in Canada.
