PROGRAMS

The Ukraine Humanitarian Relief Committee has been established jointly by the Ukrainian Canadian Congress and the Canada-Ukraine Foundation to formalize a coordinated approach in providing humanitarian assistance quickly and efficiently to those in need in Ukraine to address any further aggression by Russia.

The main efforts of cooperation are to provide humanitarian assistance/relief in the areas of assistance to displaced persons, medical care, emergency shelter and food security.

Current news update: "February 24, 2022. TORONTO/OTTAWA – The Ukraine humanitarian appeal established by the Ukrainian Canadian Congress (UCC) and the Canada-Ukraine foundation (CUF) today announced a major update on its fundraising efforts to respond to the humanitarian crisis ensuing from the current Russian invasion of Ukraine. Members of the Ukrainian Canadian community, many of our friends and colleagues across Canada, community organizations, provincial governments and a major donor have responded to the appeal and helped us exceed the preliminary Phase I target of \$1.5M. Today we are announcing a Phase II target of \$5M aimed at continued supplies of food and medicine for displaced Ukrainians".



VISION / MISSION

Mission: To support the continuing work of the Canada-Ukraine Foundation in delivering assistance projects generated by Canadians to Ukraine. Donations ensure their programs and committees receive the funding they need to provide lifechanging aid to Ukraine, especially during these troubled times.



INITATIVES OUTSIDE OF THE CURRENT CONFLICT

Health Care – The Health Advisory Team (HAT) aims to be the partner of choice for Ukrainian healthcare institutions, NGOs, and various levels of government health ministries to build capability and capacity within Ukrainian healthcare systems and communities. Through CUF supported and sponsored programs and projects, they promote health by enabling organizations, healthcare practitioners and healthcare promotion advocates to improve the healthcare in the communities that they serve.

Education -The CUF Education Committee works to promote cooperation between Canadian and Ukrainian educators for the purpose of professional development and strengthening the standard of education in Ukraine. This is achieved by the creation of resources, facilitation of workshops and management of programs.

Civil Society – The CUF Civil Society Committee was formed to provide a framework for review and support of projects and programs that promote social justice and sustainable development in a free and democratic Ukraine. The mission of the Civil Society Committee is to support, enable and empower individuals and organizations in Ukraine to implement just, transparent, inclusive and democratic national policies, in efforts to contribute to sustainable development and enhance a learning culture for a civil society.



COMMENTS

The Canada – Ukraine Foundation receives most of it's funding from other registered charities and the Canadian Government (Provincial & Federal). In 2020, 94% of it's revenue was used to deliver programs aligned with their mission, with only 6% being directed toward administration. Since the Russian invasion began, the organization has received \$1 Million from the Province of Alberta, \$100,000 from Saskatchewan, \$150,000 from Manitoba, \$300,000 from Ontario and \$750,000 from the Temerty Foundation, with many smaller donations coming from generous Canadians. To date, the organization has raised \$2,390,000 of the \$5,000,000 target to support the Ukraine Humanitarian Appeal.
