The Canadian Foodgrains Bank is a partnership of 30 Canadian denominations, churches and church-based agencies working to end hunger in developing countries. Its charitable programs include provision of food to hungry people, funding of programs to improve nutrition, assist communities and households to feed themselves, educate Canadians about international hunger issues, and advocate for policy changes necessary to end hunger. The international program is delivered through its member agencies and their operational partners in developing countries.



VISION / MISSION

“Canadian Foodgrains Bank is rooted in the belief that humankind is created in the image of God and that it is God’s desire that no person should go hungry”.



INITIATIVES

Emergency Food Assistance – The organization addresses the need of millions of people facing hunger each year due to conflict, climate change, political upheaval, natural disasters and economic disruption. The organization provides emergency food and nutrition assistance, including additional support to pregnant/nursing mothers and children experiencing the harsh realities of war and natural disaster.

Long-Term Responses – This includes helping to rebuild livelihoods after a crisis, promoting sustainable farming practices, and working with communities to build resiliency. We also work with families to support nutrition, hygiene and sanitation, through maternal health education programs.

Engaging Canadians & Governments – Rally Canadians to work together to end global hunger through giving, learning, praying and advocating. They also engage decision makers in government to improve and enact policies needed to end world hunger.

Projects Around The World – Working with 100 international partners in 70 developing countries to end world hunger.



COMMENTS

The Canadian Foodgrains Bank Association is a very large Christian organization with over 50 full & part time staff dedicated to ending world hunger. As an update to the above 5 year graph, the organization raised over \$55 Million in 2021. Of this, 51% came from the Federal Government and the balance from Donations & Gifts from Other Charities. Total expenditures were over \$47 Million, with 93.5% of this being used to support their mission. A total of 6.5% was used to cover Administration, Payroll, Occupancy Costs and Fundraising Initiatives. These are very good financials that fall well within the CRA approved guidelines.

Although the organization did not include Ukraine in their list of countries they typically support, they are responding to the humanitarian crisis there. We have spoken with them and like all other NGO's providing aid to the Ukrainian refugees, they cannot disclose the details regarding their supply and funding channels due to safety concerns. They have assured us that they are focused on delivering food and nutrition with special attention to pregnant/ nursing mothers and children, both within the country and on the borders.

Canada Gives would not hesitate to recommend this organization for funding. Donors should be aware however that if the organization is unable to deploy all of the funds raised for a specific campaign (such as Ukraine), they reserve the right to redirect the funds elsewhere as needed. For a humanitarian crisis as large as Ukraine, this is not likely a concern at this time but just something to be aware of.
