MSF is in the process of re-evaluating their services in Ukraine to best meet the new and ever-increasing humanitarian crisis. They are committed to remain in the area and support the people of Ukraine as they face these new challenges.



VISION / MISSION

Vision: Medical aid where it's needed most. Independent. Neutral. Impartial.



MSF runs a range of activities in Ukraine, including tuberculosis (TB) and HIV programs. They have recently started new projects in Donetsk and Luhansk, while also continuing to support the national COVID-19 response.

The situation in Ukraine is fast-evolving, so they are mobilizing a general emergency-preparedness response to be ready for a variety of potential needs. Their teams in Belarus and Russia stand ready to provide humanitarian assistance if needed and are looking to send teams to other neighbouring countries to be ready, either for response in Ukraine or to provide humanitarian medical assistance to refugees seeking asylum abroad. Their supply centres are currently working on readying medical kits for rapid dispatch. They will need to evaluate over the coming weeks what access will be possible in a safe and impartial manner for humanitarian assistance.



COMMENTS

Canadians are publicly being urged to support MSF given their ongoing and consistent presence in Ukraine since 2014. If a large gift is under consideration we would suggest that Canada Gives contact MSF to discuss their response to the Russian invasion and confirm that they are able to continue delivering much needed services to the Ukrainian population throughout this crisis. Annual revenue is made up of of 73% donations from the general public, 12% government grants and the balance from other registered charities and corporate sponsorships. Of this, 88% is used to support their global programs with only 3% covering administrative expenses. The organization is highly regarded in the non-profit sector and has successfully delivered humanitarian relief and medical care to over 70 countries worldwide since their inception in 1988.
