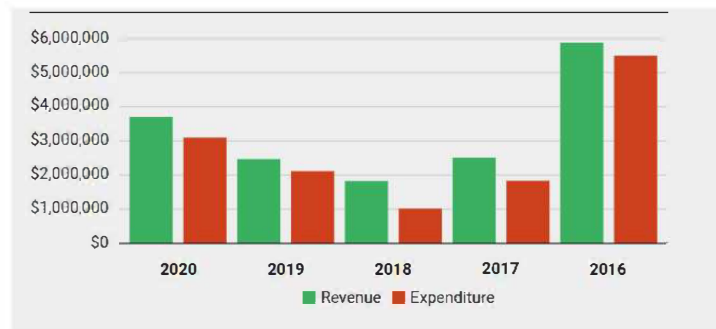

The majority of the organizations 2020 revenue of \$6.7M was received from other registered charities opposed to new donations or through fundraising. They current receive only a small grant of government support. They directed over 97% of this to programs to fulfill their mission. Administrative costs were less than 3% which is impressive. The organization is operated by 7 full time employees, 6 part time employees and volunteers. They operate in the following countries: Syrian Arab Republic, India, Bangladesh, Ecuador, Mozambique, Haiti, Philippines, Somalia, Yemen and Ukraine.
