They continue to support local non-governmental partners in these countries to deliver effective projects and services in the areas of: Education (formal, non-formal, vocational training); - Health, Nutrition - Humanitarian programming in emergency situations, including in conflict-affected countries. Child protection programs (including programs to eliminate gender-based violence, child and early forced marriage, and the creation of child-friendly space centers in emergency situations).

Save the Children Canada has committed to provide urgent humanitarian assistance to children and their families in Ukraine as a result of the Russian invasion.



COMMENTS

Save the Children has been working to support children in over 120 countries since 1967. They have publicly announced their commitment to support the children of Ukraine who are caught up in Russian invasion. Nearly 69% of their revenue comes from the Canadian federal government with the balance coming equally from individual donors, other charities and corporate sponsorships. Administration and Fundraising makes up just over 20% of their expenses with the balance of revenue being used for delivery of programs.
