## **PROGRAMS**

The Canadian Red Cross society is part of the largest humanitarian network in the world, the International Red Cross and Red Crescent Movement. This network includes the International

Committee of the Red Cross (ICRC), the International Federation of Red Cross and Red Crescent Societies (Federation) and 192 national Red Cross and Red Crescent Societies dedicated to improving the situation of the most vulnerable throughout the world.

The Canadian Red Cross has launched the Ukraine Humanitarian Crisis Appeal to respond to those affected by ongoing conflict in the country. Donations to the Ukraine Humanitarian Crisis Appeal will enable the Red Cross and Red Crescent Movement to respond to humanitarian needs resulting from almost eight years of conflict, as well as preparedness and response efforts due to heightened tensions in Ukraine. Support will address immediate and ongoing relief efforts, long-term recovery, resiliency, and other critical humanitarian activities as needs arise, both in Ukraine and surrounding countries, including those who are displaced.



# REVENUE AND TOTAL EXPENDITURES



### COMMENTS

The Canadian Red Cross is a very large organization with over 6000 full time and part time employees worldwide. In 2021 their revenue surpassed \$560M. Nearly 70% of this revenue comes from Canadian government grants at all levels. Of this 88% is used to deliver the programs under their mission with the balance being used for administration (3%) and fundraising (9%). In response to the crisis in Ukraine, the Canada Red Cross had raised more than \$60M by March 4, 2022, (50% of which was matched by the Canadian Federal Government). The organization is a massive "fundraising machine" and although they do essential work at the time of crisis there has been some controversy surrounding their use of funds. During the time of crisis donations pour into support those in need. If the Canadian Red Cross is not able to deploy all of the funds to that one purpose, they use the funds elsewhere. They do their best to align the purpose and geographical area with the original intention but donors need to be aware that their donations may not be used in the location they are hoping to support. This came to light when million of dollars were raised to support Haiti in the aftermath of the major earthquake and very little

has been used to support that community to rebuild. A similar experience occurred in the Bahamas after the hurricane levelled Abaco.

From the Red Cross website: "In the unlikely event that we raise more money than can be reasonably and effectively spent, we will strive to use any residual funds for similar purposes and/or in a similar geography and to respond to other disasters and humanitarian needs throughout the world".

This will not be an issue if the Canadian Red Cross continue to support the Ukraine population over many years. Their extent of work there will be determined by their mission and their leadership however, so donors need to be aware that their donations may be used elsewhere in Eastern Europe if not fully deployed to support Ukraine.
