RESPONSE TO FLOODING IN PAKISTAN

Through the local IDRF team in Pakistan, families are being provided with emergency food boxes and Family Emergency Kits which contain basic hygiene items such as soap, toothbrushes, female hygiene items, as well as oral rehydration tabs, clean water filtration units, and solar lights. The kits also provide mosquito nets, blankets, pillows, mattresses, and kitchen items. In addition, livestock feed for families is also being provided.

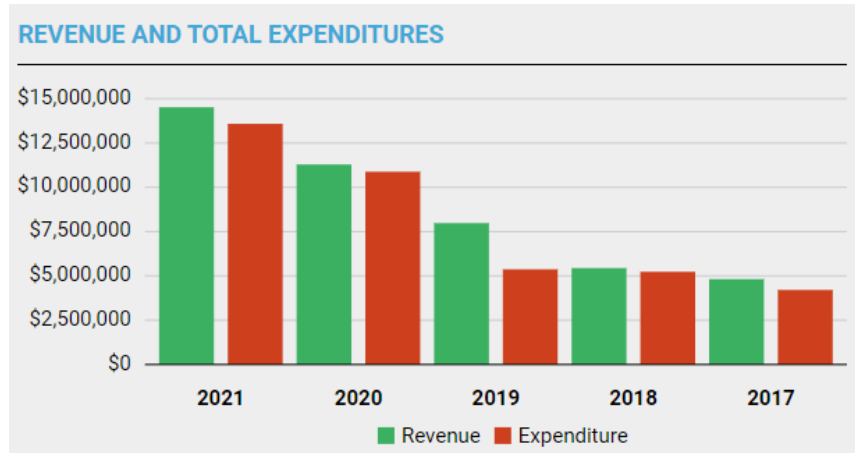
